




WTW002 Thermal Washer





Instruction Steps

- **1.** Clean all surfaces where the WTW002 Thermal Washer will contact.
- 2. Remove the protective plastic cover from both sides. The material is inherently tacky. Apply the WTW002 Thermal Washer to the WHS302 Heatsink surface, aligning the thermal washer holes with the heatsink holes.
- Secure the WHS302 Heatsink and the WXC303 or the WXC304 Fan (if fan is used) to PDIP14 Package with two screws.
