

The WEV Thermal Solution Kits allow the WLD Series Laser Diode Drivers, and the WHY/WTC/WTCP Series Temperature Controllers to operate at higher output powers, and across a wider ambient temperature range.

Review the Safe Operating Area calculator for your device to determine which WEV kit is appropriate for your application.

COMPACT, VERSATILE, AND EASY TO USE

Assembly is fast and easy with the included mounting screws. No additional board space is required to use the WEV kit.

Fan voltage requirements are 5 V or 12 V, depending on the kit selected.



ASSEMBLY INSTRUCTIONS





Figure 1. Exploded View of WEV Kit Assembly

Refer to Figure 1.

- Clean all mating surfaces on the electronics module and heatsink. It is important to remove particulates and foreign materials from the mating faces.
- Apply the WTW002 Thermal Washer to the WHS302 Heatsink surface, aligning the thermal washer holes with the heatsink holes.
- Secure the WHS302 Heatsink and the WXC303/304
 Fan (if used) to driver/controller with two screws.
